








ACADEMIC PROGRESS


The academic goal of Wright Preparatory Academy during the 2022-23 school year was to achieve three stars on all applicable components of the Ohio Report Card.

In 2021-22, Wright Preparatory Academy received 3 stars in one of four components. In 2022-23, Wright received 3 stars in two of four components, making a 25% increase. Although the school fell short of goal, Wright Preparatory Academy met state student progress expectations in both ELA and Math.
